# 2017/122 Ward Member's Update

Cllr Neil Buckley gave an update about the recent occupation of the village green by a group of Travellers. A number of Parish Councillors, the three Ward Councillors, 5 PCSOs and another member of the police force all attended on site. Leeds City Council's Gypsy Liaison Manager also provided advice. Following Cllr Buckley's visit to neighbouring shops and businesses the police agreed to escalate the legal procedure for evicting the Travellers from the site under Section 61 of the Public Order Act. Once the eviction has taken place, Cllr Buckley has arranged for the Leeds City Council's Localities Team to move onto the site and carry out an extensive clean-up operation. Cllr Buckley also advised the meeting that he

intended to ask for this issue to be added to the order paper for the next meeting of Leeds City Council next week and would take this opportunity to request some financial help with the clean-up costs and to ask what could be done to protect the village green and to prevent a re-occurrence in the future.

The local residents thanked Cllr Neil Buckley and the Parish Council for their swift intervention in this matter.

- Front garden competition Cllr Allen advised the meeting that the judging had taken place on 27<sup>th</sup> June and there was one winner and two runners-up. A formal ceremony will take place on 10<sup>th</sup> July at the ACA. The Working Party now need to forward a list of names and addresses to the judge and to notify the entrants. Cllr Parker gave a summary about the competition of the 21 original entrants, three had withdrawn before the judging took place leaving 18 in the competition. Richard Gill from Leeds City Council had been extremely helpful and it was agreed that the Clerk would formally write to thank him for his help and advice. The Clerk was also asked to write and thank the competition judge.
- Band concert Cllr Lyn Buckley gave an update about the recent band concert.

  This was extremely well-received. Unfortunately the After Hours quintet are unable to

play at the concert on 20<sup>th</sup> August and their place has been taken by a group called Kibitz who play both klezma and jazz music.

the Book Festival and possibly to sell tickets at the ACA summer gala on 16<sup>th</sup> July.
