 have now been received to the Parish Council's proposal from Yorkshire Water,
 Leeds City Council and Zurich Insurance none had raised any objections. It was
 agreed that Cllr Hainsworth would draft a leaflet to be circulated to local residents in
 the immediate area.
- 2016/200 Friends of Buckstone Grove footpath it was agreed that this item can now be removed.
- 2017/071 Alwoodley Parish Council Neighbourhood Development Plan following a discussion about the wording relating to the provision of primary school places it was agreed to accept the recommendation from David Burgess. Cllr Pearlman advised the meeting that the discussion with Natural England about the Neighbourhood Plan has now been resolved.

- **Website** a mock-up of the website is now available and the Clerk agreed to circulate the details. The Parish Council were asked to forward any comments to the Clerk.

A request from a local resident from The Crescent to turn the grass verge outside her house into a parking space has now been referred to Highways. During a recent visit to streets in the Buckstones, Cllr Buckley had received a very good reception about the work of the Parish Council and local residents had raised their concerns about parking on

pavements and grass verges. Following the Annual Meeting of the Parish where a vote was taken about the proposed 20mph speed limit, the Ward Councillors are now waiting to meet Bobby Virdi to discuss the proposal.
