2324/121 Introduction from the Chair

Cllr White welcomed all to the meeting. Members expressed their condolences on the passing of Cllr Hainsworth's wife.

2324/122 Public Participation

Alwoodley Climate Action Hub circulated a leaflet in which some of their projects highlighted. Ward Cllr Lyn Buckley questioned where the tree planting will be and that LCC would be consulted.

Part of the presentation is to enlarge the garden area around the memorial on the grass verge on King Lane. Concern raised as to if the garden becomes an eyesore in the future who would put it back to how it is now. It was felt as long as it had LCC permission they would take responsibility for this.

- b) To discuss 8 step process for Alwoodley to become a Parish of Sanctuary (HK)
 Discussions as to what is the next step the Parish Council needs to take bearing in mind we do not have a clerk at the moment. A small working party might be the way forward. It was also stressed that the sanctuary offered is to all people.
- c) To receive an update on the Community energy project
 Request to use the ACA as a postal address. There is a meeting on the 5th November with the ACA to discuss / approve this.

2324/128 To consider matters requested by Councillors and agree any necessary action

- To receive financial update
 This will be circulated to councilors when available.
- b) To consider grant applications as required None reported
- c) To consider the financial limit for grant awards
 The current limit is £1000. It was proposed the £1000 limit remained but that the council might
 consider one off larger grants if they can show a greater benefit to the Parish. So the greater the
 grant the more information will be required. Only one grant per financial year was possible.
- d) To consider additional playground equipment (RH)

 Cllr Hainsworth suggested a traversing wall. Concerns were raised on it being a wooden structure

 which may be costly to maintain and may also not meet safety requirements.
- e) New addresses are ready to go. Cllr White advised that details would be circulated later.

 There had been a meeting with LCC footpaths officer Bob Buckingham to request an improvement
 to the Crag Lane footpath. It was agreed this could well be done but LCC would want probably want
 financial support from the Parish Council.

 Staffing: Lengthsman/Ranger role to be advertised as a self employed role. Advert for a new clerk
 to be agreed and advertised through the Yorkshire Association and National Association. It was
 agreed the successful candidate should have experience of being a clerk and must have, or be
 actively working towards, a qualification.
