Members received a short presentation from Donna Russell, the Centre Manager at Herd Farm. She explained what the centre did including residential and day courses. She is planning an orienteering course which to establish would cost £1,017. She was asked how the work of the centre benefitted Alwoodley residents in particular and the question of discounts and open days for Alwoodley people was mooted. She was asked to submit a formal grant application to be considered at the next meeting.

Christine Kinsey from St Barnabas Church outlined the reason for the grant application for repairs to the roof of the church and explained the sources of funding already received for the project. Members agreed to the application subject to any legal restrictions as the amount requested.

The Friends of Heath Nursery Wood grant application was considered. The group need to open a bank account to receive any grant funds the Council might offer. It was agreed a revised application should be submitted including additional information on the cost of signage and other costs.

c) To appoint an additional member to the Staffing Panel Cllrs Jennings and Wright agreed to join the panel.

A proposal to call the new appointee to the role of Lengthsman "Ranger" was discussed along with how biodiversity issues could be added to the role and also how residents could be mobilised to join this.
